## Our History

The Eryldene Trust was formed in 1979 to acquire the property known as Eryldene, and to conserve its heritage values, especially the complimentary value of its Architect and its owners, the late Professor E G Waterhouse and Mrs Janet Waterhouse, and the Camellia collection, the garden landscaping and house, and the character of the place. The purpose of the Trust is to conserve the place as a museum, library, art gallery and garden open to the public

Eryldene is an early 20th century historic house (1914) and garden designed by visionary architect William Hardy Wilson for Professor E G Waterhouse, who created its internationally acclaimed Camellia garden. The garden was developed by its owner to a remarkable individual character and was the setting for his world-renowned efforts in developing the nomenclature and hybridisation of Camellias. It remains a resource for their study to this day.

The Eryldene Trust is an independent organisation and registered charity. We are not funded by government. We depend on volunteers and generous supporters to enable the place to open to the public and manage conservation, maintenance and other activities. Eryldene is listed on the State Heritage Inventory, the Register of the National Estate, the local heritage list and the Register of the National Trust of Australia (NSW).

## Chairperson's Report

## For the Year Ended 31 December 2020

The last year has been very difficult for Eryldene with hardly any income and the need to safeguard many of our experienced volunteers from face to face contact with the public. The Trustees have been extremely active, reducing expenses, managing garden and house conservation needs and initiating strategic responses for the situation ahead.
The Trustees were very pleased to be joined by accountant Jonathan Karanikas in September as our new Treasurer for both the Trust and Foundation. He has committed his time to updating our financial arrangements and in the face of the pandemic, managing our budgets tightly and efficiently. He has also engaged the musical element of our Open Sundays, finding a new audience stream for Eryldene.

Although almost all our income streams have virtually halted since March 2019, many of our expenses continue- insurance, maintenance, conservation works. Recognising the impacts of the pandemic the Trust undertook a series of strategic planning meetings; and immediately tightened our financial expenditures. Our employment of a site manager ceased as did all events and public programming. A range of bookings were cancelled, and our venue hire activity stopped as Covid restrictions increased. Our grateful thanks to Anne Galbraith for keeping Eryldene updated and compliant on Covid Safety Planning issues (as well as being minutes secretary through the end of 2020).

Under the watchful eye of Hon Curator trustee Penny Holden and Hon Architect Robert Moore, the Trust has remained committed to its mission of caring for Eryldene by focusing on repair and repainting works for which funds were raised by the Foundation in the last three years - ceilings, vulnerable timber work to the western side of the house.

Good housekeeping - the essence of conservation - has been maintained: cyclical gutter cleaning - basic to the safety of any roof and the building below it; pest eradication; airing rooms and rugs; weeding and gardening. Ongoing assistance from Ku ring gai Council is invaluable in these efforts, many thanks to Cheryl Szatow for her commitment. . Our Honorary Conservator Julian Bickersteth continues to support the care of the collection, this year with a focus on paintings with grant support from the Copland Foundation.

The rejuvenation of the camellias continues with repotting of the large camellias to start soon, under Trustees Helen Wallace and Juliet Muras' watchful eyes and Trustee Bruce Walker is comprehensively reviewing the garden watering system. Financial restrictions as a result of Covid have necessitated the landscape contract being halved, and we welcome new garden volunteers to help its management and maintenance. This year we appointed landscape specialist Colleen Morris as our Honorary Garden Adviser, with an eye to reviewing our garden practice and philosophy, also an essential component of the new Eryldene Conservation Plan development currently underway.

In January, museum professional Suzanne Bravery joined the Trust, and she has been successfully re-organising the Eryldene volunteer program and helping us with grants applications. It's wonderful to have the range of museum and historic house experience joining the Trust at this time, when training volunteers is so essential.

All the Trust Board members have stepped up to take on many of the administrative tasks needed to keep Eryldene open, in the absence of being able to continue to employ a site manager. We have successfully applied for a number of grants to support Eryldene, and have recently received a commonwealth grant to repair and relay sections of our original sandstone paths improving safe access within the garden for all ages and levels of mobility. Through the Bendigo Bank we received a $\$$ for $\$$ matching grant for all donations made between 17 May - 18 June. This will help upgrade our Website, a much-needed resource. To assist such fundraising activities an Eryldene tea towel was designed by our Hon Architect, Robert Moore is for sale at the Bendigo Bank branches and on Open Sundays.

Trustee Judy Coombes is now leading an Events subcommittee organising a programme of Sunday garden openings began on Mother's Day with the legendary Afternoon teas; and the gardens will continue to be open for each Sunday in May, July, September and November. Our thanks to former trustee Wendy Sadler Moyes for her help in supporting this concept. Local musicians are giving their talents each morning, and Eryldene volunteers man refreshments. It's a modest start to reopening but we hope to see a new group of visitors enjoying the gardens, and to be able to mount the annual Eryldene Jazz concert on 17 October.

Our temporary administration assistant Kaitlan Hora began at Eryldene in February and has already revamped our social media presence, rapidly increasing our visibility with direct results in venue hire and visitor numbers as the Covid restrictions begin to ease. We are also pleased to have a new Style Guide for Eryldene's external publications, prepared by volunteer graphic designer Clare Moore, the 2021 calendar and new signage is the start of producing all our publications in house, saving fees and costs to reduce our budget outflows. Please use Eryldene Facebook and Instagram pages for reminders about upcoming events and news. The Eryldene Review is issued twice annually with kind support of Catherine Martin and the electronic newsletters initiated during the pandemic will continue to be developed as our main communication with members.

The year concludes with painful reflection on the realities regarding our financial position. Despite tightening our expenditures, and halving our landscape contact and office staff, we cannot meet our costs and our accounts note a loss of $-\$ 34,247$ over the year, before support from the Foundation. The Eryldene Foundation has stepped up to meet the shorffall and we are grateful to donors who responded to the two appeals held this year. We must recognise that as the only House Museum in Australia run entirely by a community Trust, without ongoing government support of any kind, the impacts of Covid and indeed its aftermath, demand a very strategic response, and continuing donor support.

It is an honour to chair a group of Trustees who demonstrate such enthusiasm and commitment to the care and conservation of Eryldene house and garden. This year past has proven how much we rely on volunteers and donors to survive, and we will be continuing the development of an updated strategic plan to focus priorities on the challenges and opportunities before us, as well as prudent governance and careful conservation of this very special property

## Report on Buildings \& Collection

For the Year Ended 31 December 2020

During this year of lockdowns Eryldene was one of a small number of museums and galleries able to open its front gate to visitors to the garden. Covid restrictions and our Covid safety plans however kept the house closed. The opportunity was therefore taken to complete a number of restoration works to house ceilings and the two loggias through funds raised by the Foundation over the last three years. The outside walls and the timber balustrade of the western loggia, most vulnerable to the effects of the afternoon sun, have also been stipped, primed and repainted.

Eryldene was the surprised and very grateful recipient of a four-drawer cedar chest from the estate of Joyce Mills. The chest is possibly the one depicted in lan Waterhouse's mud map of his father's bedroom, and is accompanied by a letter written by EGW when he sold it in 1942, in which he dates the chest to about 1840 and comments that it is not easy nowadays to find such good pieces.

Through the generous gift of the Copland Foundation the first stage of the restoration of an oil painting attributed to the Flemish Baroque artist, Jordaens, was accomplished. The painting has hung above the sideboard in the dining room and was photographed there by Cazneaux in 1927. It is hoped the second stage of its restoration can be funded in 2021. The Copland Foundation also supported the restoration of wooden and leather hand painted Japanese bellows, part of EGW's Asian collection in the garden study.

A catalogue of the furnishings, art works, artefacts and fillings of the garden sludy was completed by Sydney University student intern, Kaitlan Hora, her work table idyllically placed in the outside air between fountain and study door.

Eryldene was grateful for the support of Ku ring gai Council, through two Community Grants: one to provide equipment for the house keeping/gardening work of the volunteers, and one to provide specifically constructed archive boxes to safely house and display the ancient Asian textiles collected by and given to EGW during his lifetime, and the Waterhouse household linens, part of the story of the use of the house as a family home. Council staff also came to handwash verandah and garden study eaves and timber work, an essential part of Eryldene's ongoing conservation housekeeping. It was particularly appreciated this year as our annual volunteer working bee for the verandah and loggias had to be cancelled.

In the early stages of the pandemic Eryldene adhered to government advice to avoid face to face contact between our more vulnerable volunteers and the public. This and the requirement for stringent Covid cleaning of interior spaces where the public might go precluded all tours of the house and its interpretation. Special small group tours will hopefully be possible in 2021 with Eryldene's volunteer guides engaged once more with the architecture, art and multifaceted stories which augment any visit to this state heritage listed place.

## Garden Council Report

## For the Year Ended 31 December 2020

This past year has been eventful in several ways. Because of Covid 19 and lack of funds the contract gardeners are not working as frequently as they have in the past which has meant that the volunteers need to 'pick up' some of the essential tasks in between the gardeners' visits. Fortunately we have been able to secure several new and enthusiastic garden volunteers which has made this easier and at the time of writing - (as camellias begin to bloom) - the garden looks as healthy and tidy as we would wish.

In September 2020 there was a most generous donation made to the garden, which enabled us to undertake a huge pruning programme. We were able to employ Bill and Luke Parker (Camellias R Us) and Craig Carroll for three days to undertake massive pruning of most of the camellias on the property, some of which had not been properly pruned for $25-30$ years. Teams of volunteers worked tirelessly to clear the prunings and we were most grateful to Kuringai Council for collection and removal. The final result, especially on the east side of the house was astonishing. Much more light sky and sun, and individual specimens now discernable where before there was a solid wall of foliage. The next part of this project is due to commence later in June when a number of the camellias growing in the larger concrete tubs will be repotted.

We have finally been able to clean up debris from the big storm 18 months ago in November 2019. The service area behind the garden shed has been cleared, most of the fallen timber disposed of and one of our dedicated volunteers has established a compost heap. Also the damage in the shade house has been repaired.

Volunleers meet and work every Friday, and in 2020 (cualendar year) worked for 820 hours in the garden.

## Treasurer's Report

## For the Year Ended 31 December 2020

The financial impact of COVID-19 was unprecedented across all industries of our, and indeed the worldwide, economy. Its impact on the arts and culture sector, due to the reliance on gathering size in generating revenue, was even more severe. In the case of Eryldene, social distancing restrictions and lockdowns only saw operating revenues from tours and events fall by $76 \%$ from $\$ 100,647(2019)$ to $\$ 24,690(2020)$. While directed efforts were made to reduce operating expenses considerably, unavoidable costs incurred resulted in a loss for the year, before calling on the foundation for support. The Foundation was able to further distribute to the Trust $\$ 52,000$. Of this $\$ 52,000, \$ 29,550$ has been capitalised for expenditure on future projects in future financial years.

The damage to the property caused by the storm in late 2019, requiring over $\$ 40,000$ in repairs, was mostly funded by an insurance payout of $\$ 36,972$ received.

Thanks to the generous support of donors, the Trust received direct donations of $\$ 22,348$ and a bequest of $\$ 5,000$, in addition to support from the Foundation. The profit \& loss statement shows a net surplus of $\$ 13,113$; after adjusting for this and other extraordinary income and expense items, the actual operating loss for the year amounted to $-\$ 31,482$, reconciled as follows:

After 1 July, and with multiple COVID-safe plans in place, the garden was opened again for open days in July to September. This was followed by 3 open days in November. While these events in November were largely supported by volunteer efforts, the costs to run each were significant in proportion to the revenue each generated and, while these events achieved the purpose of presenting Eryldene to the community, they did not significantly add to the bottom line. ## Governance

The financial report covers The Eryldene Trust as an individual entity. The Eryldene Trust is a not-for-profit Company limited by guarantee, incorporated and domiciled in Australia.

The functional and presentation currency of The Eryldene Trust is Australian dollars.

The accounting policies adopted by the Company and comparatives are consistent with prior years, unless otherwise stated

## 1 BASIS OF PREPARATION

The financial statements are special purpose financial statements that have been prepared in accordance with the Australian Accounting Standards and Australian Accounting Interpretations of the Australian Accounting Standards Board (AASB) and the Australian Charities and Not-for-profits Commission Act 2012.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in financial statements containing relevant and reliable information about transactions, events and conditions.

Compliance with Australian Accounting Standards ensures that the financial statements and notes also comply with International Financial Reporting Standards.

Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless otherwise stated

The financial report has been prepared on an accrual basis and is based on historical costs and does not take into account changing money values. Cost is based on the fair values of the consideration given in exchange for assets.

## 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

(a) Income Tax

The Company is exempt from income tax under Division 50 of the Income Tax Assessment Act 1997.
(b) Revenue and other income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the Company and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable.

## Interest revenue

Interest is recognised using the effective interest method.

## Other income

Other income is recognised on an accruals basis when the Company is entitled to it.
(c) Land

Land has been separated from Buildings at its cost at purchase, namely $\$ 140,000$. Revaluation, based on Heritage Land Valuation by the NSW Valuer General, dated 1 July 2020 has been adopted by Directors resulting in an Asset Revaluation Reserve of $\$ 2,560,000$ and Land at valuation of $\$ 2,700,000$.

(d) Property, Plant \& Equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment.

Items of property, plant and equipment acquired for nil or nominal consideration have been recorded at the acquisition date fair value

Where the cost model is used, the asset is carried at its cost less any accumulated depreciation and any impairment losses. Costs include purchase price, other directly attributable costs and the initial estimate of the costs of dismantling and restoring the asset, where applicable.

Assets measured using the revaluation model are carried at fair value at the revaluation date less any subsequent accumulated depreciation and impairment losses. Revaluations are performed whenever there is a material movement in the value of an asset under the revaluation model.

The carrying amount of plant and equipment is reviewed annually by the directors to ensure it is not in excess of the recoverable amount from these assets. Buildings are measured on the fair value basis, being the amount for which an asset could be exchanged between knowledgeable willing parties in an arm's length transaction.

## Depreciation

Property, plant and equipment, excluding freehold land, is depreciated on a straight-line basis over the asset's useful life to the Company, commencing when the asset is ready for use.

Depreciation of Buildings ceased at 31 December 2007 as the Directors are of the view that the Buildings do not warrant impairment beyond that which has accrued to date.

(e) Inventories

Inventories are measured at the lower of cost and net realisable value. The cost of inventories is based on firstin first-out principle, and includes expenditure incurred in acquiring the inventories and other costs incurred in bringing them to their existing location and condition.
(f) Heritage assets

Heritage assets held by the trust include assets of cultural significance and value, for which generally no market is readily available to measure its value. Heritage assets held by the Trust include a collection of significant items, and camellias. These assets are not recognised on in the financial statements as their value cannot be reliably measured, and are recorded at a nominal value of $\$ 1.00$ in total.
(g) Goods and services tax (GST)

Revenue, expenses and assets are recognised inclusive of any amount of goods and services tax (GST). The Company is not registered nor required to be registered for GST, consequently no amount of GST incurred is recoverable from the Australian Taxation Office (ATO).
(h) Cash and cash equivalents

Cash and cash equivalents comprises cash on hand, demand deposits and short-term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value.
(i) Trade and other receivables

Trade debtors and other receivables represent the principal amount due at balance date plus accrued interest and less, where applicable, any unearned income and provisions for doubtful accounts.
(j) Trade and other payables

These amounts represent liabilities for goods and services provided to the company prior to the end of the financial year which are unpaid. The amounts are unsecured and are usually paid within 60 days of recognition.
(k) Volunteers

AASB1058 Income of Not for Profits requires the Company to include the value of the work provided by volunteers. The Company has determined that the valuation of work provided by volunteers would be extremely difficult to assess and would be unable to be reliably estimated and so has not been adopted in the financial statements.
(I) Adoption of new and revised accounting standards

The Company has adopted all standards which became effective for the first time at 31 December 2020, with the exception of AASB 1058 Income for Not for Profits. The absence of the adoption of this standard has not caused any material adjustments to the reported financial position, performance or cash flow of the Company.

The directors make estimates and judgements during the preparation of these financial statements regarding assumptions about current and future events affecting transactions and balances.
